## Navy Federal Credit Union Selected for FORTUNE's 2014 List of "100 Best Companies to Work For"

VIENNA, Va. (January 16, 2014) – [Navy Federal Credit Union](http://www.navyfederal.org) today was named to FORTUNE Magazine's 2014 "100 Best Companies to Work For" list. This marks the fourth time that the credit union, serving the U.S. Armed Forces, Coast Guard and Department of Defense employees and their families, appeared on the list. It remains the only credit union ever selected for the accolade.

"We are so honored by this recognition. Our employees truly connect with our mission of service—it's a culture that they live daily," said Navy Federal Credit Union President/CEO, Cutler Dawson. "To put it in the words of one employee: 'I am proud to work for a company that supports our military and our military families. In the last year, Navy Federal's workforce grew by over 14 percent. More than 11,000 employees work on its three campuses—Vienna, Va., Winchester, Va. and Pensacola, Fl.—and 245 branches worldwide. "Our employees each bring a unique talent to the organization, but there's a unifying bond," continued Dawson. "We do the right thing, and we do things right—this passion for service translates to our members and the communities we serve."
